

Mandate to Stop Fluoridation (of the Barwon Water region)

This is a simple, direct, constitutionally powerful directive to Parliament to cease fluoridation (or plans for fluoridation).

It is a new document & campaign that commenced April 2009.

The signing booths on the streets and other public places use special duplicate pads.

This ONLINE procedure for signing utilizes a printable single sheet Mandate form, that you mail to BAFF, and BAFF will submit on your behalf and copy for filing record purposes.

STEPS

1. Print out the uncompleted Mandate form (page 2 of this pdf file);
2. Complete it carefully in blue or black pen, ensuring
 - (i) clear, legible handwriting,
 - (ii) name written twice, at top and lower down,
 - (iii) tick for your Shire or council area,
 - (iv) date it clearly with day, month & year,
 - (v) full address including suburb, then postcode on next line
 - (vi) signature at bottom;
3. Every person in the household who is 18 years old or above should do a separate form;
4. Send the completed forms to Barwon Freedom from Fluoridation Inc. by mail:

NOTE: In addition to completing this mass community mandate, it is advisable to write your individual letter to all relevant authorities (and file their replies) expressing your WILL and your direction regarding water fluoridation.

the Victorian Premier,
your state and federal members of parliament,
managing director and chairman of Barwon Water,
Victorian Governor.

Mandate to Stop Fluoridation

TO:

The Members of the Victorian Parliament Assembled
Parliament House

I,, a duly qualified resident of the State of Victoria, acting with my full capacity as a Sovereign Australian, hereby Express My Will and instruct via this mandate the Victorian Parliament Assembled to stop all fluoridation of any water supply within the Barwon Water District and to prohibit the implementation of the *Health (Fluoridation) Act 1973* within the Barwon Water District by any entity.

I further mandate that the Victorian Parliament Assembled not enter into any negotiations with any entity to establish any like processes anywhere within the Barwon Water District. These instructions are to remain in perpetuity to uphold individual free will with regard to personal choice of health treatments.

This mandate is to be carried into full effect of law within 90 days of the delivery of this mandate to the Victorian Parliament Assembled.
